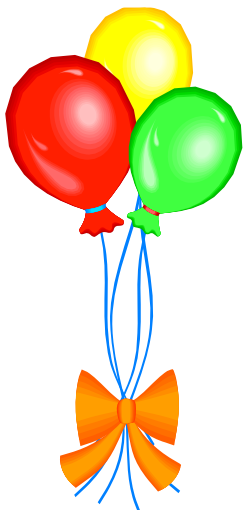

Information Sheet to Participate



Welcome to Children & Youth Day! We are so glad you chose to participate in this fun, informative, and eventful day. Last year, we had over 2,000 visitors! Have fun and please help the sponsors by following the criteria listed below. Thank you for your help and participation!

1. Every participant must have an activity or give-away for children to participate in.
2. No participant set-up prior to 9 AM. *No exceptions.*
3. All your materials for this event must come through the front gate.
4. If you bring children with you, they must remain with you while you are setting up before the park opens at 10 AM.
5. There is a lot of shade in Pixie Woods, but not in the same place all day. You may wish to bring a shade awning.
6. Because of the City's contract with the concession stand vendor, food is not permitted in Pixie Woods.
7. Check-in will be at the front entrance. Please sign in and pick up your information packet.
8. Admission is FREE for children and families to attend. Ride tickets can be purchased at the Merry-Go-Round and the front ticket booth.
9. Bubble solution **MUST** be kept off the grass. If you are doing bubbles, please select a location that will not affect the grass.



Please remember that balloons and other small objects are choking hazards for children and that these items are not to be given out at Children and Youth Day.

Balloons may be used for decoration only.
